ADDITIONAL INFORMATION ALL CUSTOMERS:				
1. Low Income customers enrolled in PG&E or the Gas Company low income programs are eligible for a reduced 32-Gallon Waste Wheeler. Contact the garbage company for details.				
2. Trip Charge: A charge applied to the customer's bill if collection occurs on a non-route day. Non-route day collections generally result from a customer's failure to have the containers available on the scheduled day and time.				
3. Drive-in / In-yard Service Fee: A monthly charge that can be added to the customer's bill under County guide lines for service requested inside the customer's property line or when the customer's residence is located a certain distance from the established service route. Contact the garbage company for information regarding the County's Drive-In criteria. This charge is not applicable to disabled customers without the means of setting the containers in the public right of way for collection. Customer must present proof of medical disability.				
4. Waste Wheeler Rental Fee: A monthly fee for using more than one garbage waste wheeler at a given service level. For example, a customer who has subscribed to a 64-gallon monthly garbage service level may choose two 32-gallon garbage waste wheelers instead of one 64-gallon garbage waste wheeler, for this additional charge.				
5. Late Fees: These are imposed for all customers over 30 days delinquent. The fee is 1.5% per month of the outstanding charge, with a minimum fee of \$5.00. No prior notice is required, as this late fee policy is stated at the bottom of every bill.
